## **FOA Purpose**

The purpose of 2017-2022 HPP-PHEP cooperative agreement is to strengthen and enhance the capabilities of the public health and health care systems to respond to evolving threats and other emergencies. Effective responses will enable jurisdictions to prevent or reduce morbidity and mortality from public health incidents whose scale, rapid onset, or unpredictability stresses the public health and health care systems and to ensure the earliest possible recovery and return of the public health and health care systems to pre-incident levels or improved functioning.

## **FOA Approach**

The HPP-PHEP Cooperative Agreement logic model (attached to complete FOA) is an organizing framework that guides the use of inputs, production of outputs, and specifies intended outcomes. Through the implementation of the logic model, short-term or system outcomes will be achieved through strategies that strengthen community resilience, surveillance, epidemiological investigations, laboratory testing, countermeasures and mitigation activities, surge management for public health and health care services, information management targeting the public and partners, and coordination of system responses through effective incident management.

## **Strategies and Activities**

Awardees are expected to develop and strengthen the following six domains through the implementation of specific strategies and activities during the project period.

- Domain 1: Community Resilience
- Domain 2: Incident Management
- Domain 3 : Information Management
- Domain 4: Countermeasures and Mitigation
- Domain 5: Surge Management
- Domain 6: Biosurveillance (PHEP)

For the 2017-2022 project period, HPP and PHEP awardees must address and comply with joint, HPP-specific, and PHEP-specific programmatic requirements for the strategies and activities listed in the FOA, as well as other requirements associated with statute and HHS grant guidance. Not all domain activities have a federal requirement or a recommendation associated with it. However, awardees can propose activities that will satisfy requirements specific to their jurisdictions under each domain.
