#### **CHAP TAG**

- I H S Circular 18-01 created CHAP TAG as a vehicle to implement CHAP nationally per IHCIA 2010.
- Tribal leadership was invited to provide subject matter expertise, program information, innovative solutions, and advice to the Indian Health Service to establish a National CHAP.

#### Progress to date

Selected Tribal Leadership; Created a charter; Tribes educated about CHA/P; Tribes educated about CHA/P; Workgroups created for DHAT, BHA/P and implementation -CHA/P will come later; Multiple versions of DRAFT Interim policies have been developed and shared between TAG and IHS.

Agree to disagree - footnotes May 1, 2019 target date for DTLL



- 12/20/18 Revised draft policy was sent out to CHAP TAG with letter that it would be announced at the January 3, 2019 Tribal Leaders and Urban teleconference and a DTLL would be forth coming.
- 12/21/18 Partial Government shut down.
- 1/3/19 No announcement at Tribal and Urban Leaders Teleconference.
- 1/4/19 A letter was prepared by CHAP TAG and sent to IHS under signature of chairperson Dr. Segay's expressing CHAP TAGs concern that they did not approve the current draft being sent out for tribal consultation. Footnote: Agree to Disagree
- 2/8/19 CHAP TAG teleconference that TAG members informed IHS they need to regain our trust and listen to our wisdom. Redline the draft.
- 2/15/19 Dr. Cotton sent IHS interim policy draft with a document explaining IHS reasoning.
- 2/22/19 CHAP TAG review of IHS comments and explanations.
- 3/15/19 Dr. Cotton reviewed the redline edits.
- 4/3/19 Announced tentative May 1,19 for DTLL

#### Committee Purpose:

- Working on strategic planning for ACCB implementation - goal is May 2019
- Is developing priorities for education campaign
- Identifying ways to build quality assurance into CHAP

- Our next teleconference meeting is this THURSDAY 5/16 VIA ZOOM to review the white paper suggestions for PACCB membership options.




# Analysis of AK Standards & Procedures

### BHA Program

- Village-based counselors to provide culturally-informed, community-based, clinical services
- Provide behavioral health prevention, intervention, aftercare, and postvention
- Training and practicum requirements
- On-the-job training
- Four levels of certification

## Student Selection

- Swinomish
- Nisqually

- 18 years old +;
- HS Diploma, GED;
- Or Completion of Accredited other degree;
- Acceptance as trainee by sponsor;
- Acceptance into AAS; and
- Basic Training Application submitted 4 month prior to September start;
- Agreements for 2 years of service;

### Council of Elders

- Mentor
- Tribal Based Practices
- Ceremonies
- Language
- Community

### BHA Curricula

- Cooperative user agreements being developed;
- Planning for multiple consultations to train
  - NWIC
  - Curriculum Instructors
  - Clinical Supervisors



- Cost to develop at ANTHC was about 1 million and maintenance is about \$200,000 annually;
- Cooperative user agreements are being developed;
- \$250.00 annual fee per user;
- Regional notes will allow sites to "personalize" for TBP
