Steve and Vicki, on behalf of AIHC, stated Umair Shah has been a great friend to the Tribes and thanked him for his partnership by blanketing him. Dr Shah commented that we have gotten to where we are today by traveling together. He also recognized Candice Wilson and the DOH team for their commitment to the work as well as their words and actions. There have been many obstacles along the way that we overcame. The team at DOH remains committed to honoring Tribal sovereignty, even though he is leaving.

Loni commented regarding developing the questions for the youth survey....(I missed this)  
Steve suggested considering doing something regionally with the Tribes.

Andy commented he learned, traditionally, that stress on the pregnant mother gets passed on to the baby. Historical trauma impacts infant mortality as well. Traditional knowledge, beliefs, food is good medicine and can make a difference.

Marilyn Scott commented some of our young adult families are choosing not to have children. It is important to gather information from this group to determine impacts on future generations.
